

Issuance of Bank BGŻ S.A. Certificates of Deposit

Current report 6/2013 dated January 17, 2013.

Management Board of Bank Gospodarki Żywnościowej ("Bank"), hereby informs that on January 17, 2013 under the agreements signed on March 14, 2008 in relation to Certificates of Deposit issuance program ("CDs") the Bank issued 140 pcs. of zero-coupon CDs with total nominal value of PLN 70 000 000 and nominal value 500 000 each and with an issue price of PLN 479 671,50 each.

Certificates of deposit issue program is used to finance Bank's current credit activities.

The agreements dated March 14, 2008 relating to a program for the issuance by the Bank of Polish zloty denominated short- to medium-term bearer securities in the form of certificates of deposit up to maximum amount of PLN 2.5 billion were described in the Bank's prospectus approved by the Polish Financial Supervision Authority on April 28, 2011.
