

Redemption of Bank BGŻ S.A. Certificates of Deposit

Current report 53/2013 dated December 3, 2013.

Management Board of Bank Gospodarki Żywnościowej (“Bank”), hereby informs that on December 3, 2013 under the agreements signed on March 14, 2008 in relation to Certificates of Deposit issuance program (“CDs”) the Bank redeemed the following issue of 200 pcs. of zero-coupon CDs with a total nominal value of PLN 100 000 000. CDs were repurchased at their nominal value.

Certificates of deposit issue program was used to finance Bank’s current credit activities.

The agreements dated March 14, 2008 relating to a program for the issuance by the Bank of Polish zloty denominated short- to medium-term bearer securities in the form of certificates of deposit up to maximum amount of PLN 2.5 billion were described in the Bank's prospectus approved by the Polish Financial Supervision Authority on April 28, 2011.
