

Redemption of Bank BGŻ S.A. Certificates of Deposit

Current report 3/2012 dated January 12, 2012

Management Board of Bank Gospodarki Żywnościowej ("Bank"), hereby informs that on January 12, 2012 under the Certificates of deposit issue program agreements ("CDs") signed on March 14, 2008 the Bank redeemed the following two issues:

- 1) 100 pcs. of zero-coupon CDs with a total nominal amount of PLN 50 000 000. CDs were repurchased at their nominal value.

- 2) 30 pcs. of zero-coupon CDs with a total nominal amount of PLN 30 000 000. CDs were repurchased at their nominal value.

Certificates of deposit issue program is used to finance Bank's current credit activities. The agreements dated March 14, 2008 relating to a program for the issuance by the Bank of Polish zloty denominated short- to medium-term bearer securities in the form of certificates of deposit up to maximum amount of PLN 2.5 billion were described in the Bank's prospectus approved by the Polish Financial Supervision Authority on April 28, 2011.
