Registration of a change in the share capital of BNP Paribas Bank Polska and a relevant amendment to the Bank's Statute

Legal basis: Article 5 para. 1 item 9, Article 15 and Article 38 para. 1 item 2 of the Minister of Finance Ordinance dated 19 February 2009 regarding the current and periodic information disclosed by issuers of securities and conditions for recognizing as equivalent information required by the laws of a nonmember state (Journal of Laws of 2009 No. 33, item 259 as amended)

1. Share capital decrease

The Board of Executives of BNP Paribas Bank Polska SA (hereinafter "the Bank") informs you that it has been notified today about registration on 10 May 2013 of the Bank's share capital decrease by the District Court for the capital city of Warsaw, XIII Commercial Division of the National Court Register following Resolutions No. 10 and No. 11 of the Annual General Meeting held on 4 April 2013.

The Bank's share capital was decreased from PLN 1,434,646,300 to the amount of **PLN** 1,304,380,415.96, i.e. by PLN 130,265,884.04 by way of decreasing the nominal value of each share from PLN 50 to **PLN 45.46**.

After the capital decrease registration, the Bank's share capital amounts to **PLN 1,304,380,415.96** and is divided into **28 692 926** ordinary bearer shares with a nominal value of **PLN 45.46** each, which entitle to execute 28,692,926 votes at the Bank's General Meeting.

2. Share capital structure

3. Shareholders' structure

As a result of the capital decrease the shareholders' structure remained unchanged. It is only the nominal value of each particular shareholder's stock in the share capital that has been adjusted accordingly.

4. Amendment to the Statute

With reference to the share capital decrease, Article 6 of the Bank's Statute was amended accordingly:

Former wording:

"Article 6.

The share capital of the Bank is PLN 1,434,646,300 (in words: one billion four hundred thirty four million six hundred forty six thousand and three hundred zlotys) and is divided into 28 692 926 (in words: twenty eight million six hundred ninety two thousand nine hundred and twenty six) ordinary bearer shares with a nominal value of PLN 50.00 (in words: fifty zlotys) each."

Currently binding wording:

"Article 6.

The share capital of the Bank is PLN 1,304,380,415,96 (in words: one billion three hundred four million three hundred eighty thousand four hundred fifteen zlotys and 96/100) and is divided into 28 692 926 (in words: twenty eight million six hundred ninety two thousand nine hundred and twenty six) ordinary bearer shares with a nominal value of PLN 45.46 (in words: forty five zlotys and 46/100) each."

We enclose <u>the consolidated text of the Bank's Statute</u> determined by the Supervisory Board based on the consolidated text of the Statute binding to date, and taking into account the amendment adopted by Resolution No. 11 of the Annual General Meeting held on 4 April 2013.
