## Changes in the composition of the Bank's Board of Executives

Jacek Obłękowski was also a Chairman of Supervisory Board of Kredo Bank in Ukraine and Inteligo Financial Services. Since May 2007 - President of the Executive Board of Dominet Bank S.A. In Fortis Bank Polska he will be responsible for Business Line Retail Banking.

Mr Jacek Obłękowski remains on the position Chief Executive Officer of Dominet Bank S.A..
