At the same time, for instance the following shall be unified for all our Customers:

- Customer Service,
- phone numbers of our Phone Line, which will be transformed into the Private Line accessed by calling +48 500 970 340 or 801 399 555,
- fees and commissions connected with agreement performance,
- internet and mobile banking they shall be replaced by the modern internet banking GOonline and mobile application GOmobile.

Additionally, as regards the holders of payment cards issued to bank accounts taken over for handling by BNP Paribas Bank in October 2018, we will make available free cash withdrawals from all ATMs around the world owned by BNP Paribas Group or Global Alliance.

Please find enclosed the brochure where I clearly present the most important changes to our offer, including information on new functionalities, legal and factual bases of the changes introduced as well as information on your rights in the case of your non-acceptance of the changes in question.
