GObmobile Biznes APP ACTIVATION

Activation of the **GObmobile Biznes** application requires granting **GObmobile Biznes and mobile token** right.

The right may be granted in two ways:

- by the system Admin in the Administrator panel,
- in a paper application for **GOnline Biznes**.

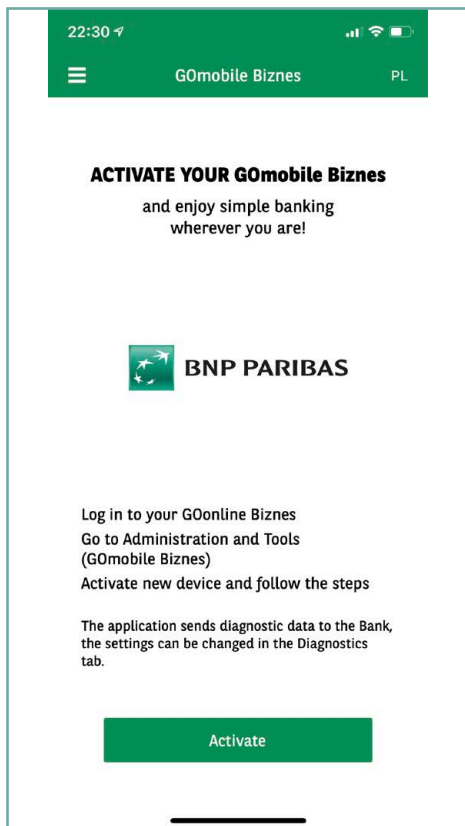

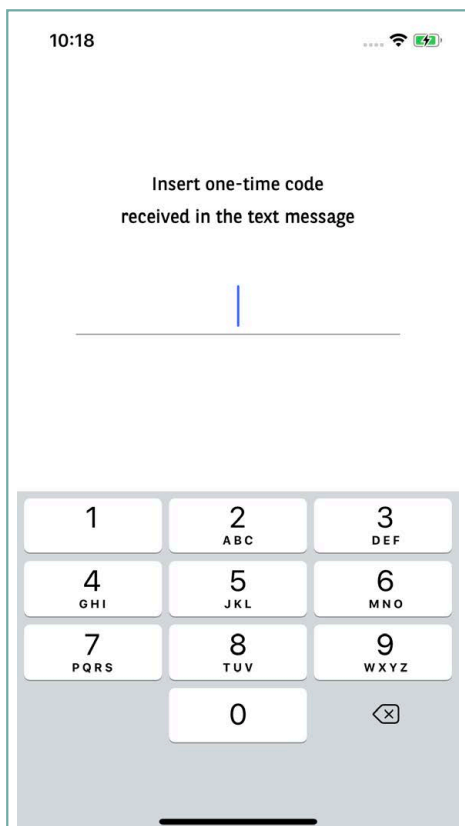

After the application has been downloaded and installed, it needs to be activated in online banking.

1. Log in to the **GObiznes** system, go to **Administration & tools**, select **GObiznes / mobile token** tab and click **Add new device**.
2. Enter the device name and click **Next**.
3. Sign the instruction with the authorization method currently used and click **Activate**.
4. Launch **GObiznes**, click **Activate** and give the required permission for making phone connections and managing them.

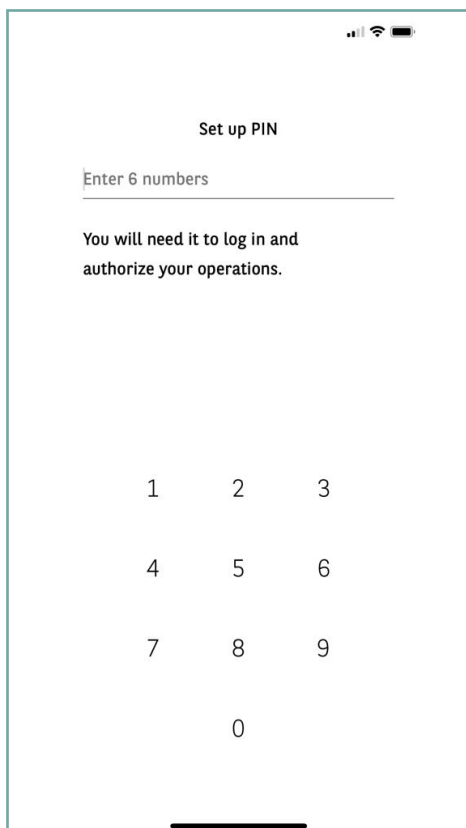


5. Enter the **one time text message code** and allow the **GObiznes** application to take photos and record films.

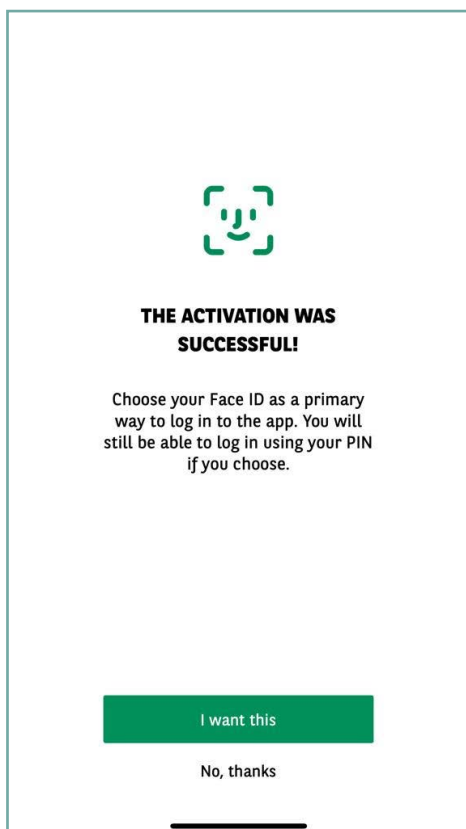

6. Scan the **QR code** displayed in the GOonline Biznes system. You may also type the code manually by using the function **Enter the code manually**.
7. Set the **PIN code** necessary for logging in and transaction authorization.



8. If you wish, you may also enable logging in with the use of **biometric** data:
 - using **Touch ID / Face ID** for devices with the iOS system,
 - using **fingerprint** for devices with the Android system.

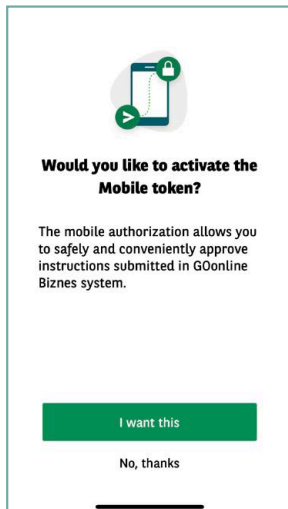

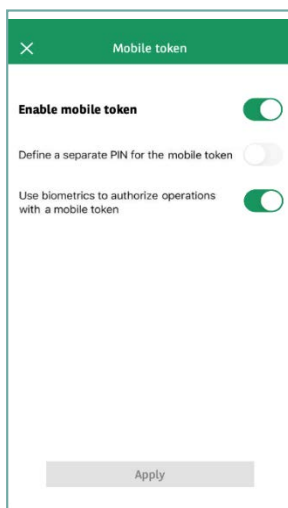

ACTIVATION OF A MOBILE TOKEN

Mobile authorization is a new method for logging in and transaction authorization. Thanks to a **mobile token** which is a part of the **GOMobile Biznes** application, you may authorize instructions placed in the **GOonline Biznes** online banking system easily and free of charge. The new authorization method ensures high level of security and convenience, and instructions may be signed not only with the PIN but also using biometrics.



1. If you want to activate the **mobile token**, click **I agree**.



2. Click **Apply** to enable the mobile token.

- A primary way for mobile authorization is the PIN number defined beforehand for logging in to the **GOMobile Biznes** application.
- The application also allows to set a separate PIN code for mobile authorization - to do this, activate an appropriate option and set the PIN number.
- Using biometrics for mobile authorization is enabled as default.



3. After the PIN has been entered, the mobile token will be activated.

CHANGING THE LOGIN AND AUTHORIZATION METHOD TO MOBILE AUTHORIZATION

Once the **mobile token** has been activated, it is necessary to change the logging in and transaction authorization method in **GOonline Biznes**.

Changing the logging and authorization method to mobile authorization requires granting **Changing the logging and transaction authorization method** right.

The authorization may be granted in two ways:

- by the system Admin in the Administrator panel,
- in a paper application for **GOonline Biznes**.

1. Log into **GOonline Biznes**, go to **Administration & tools** and select **Changing the login and authorization method tab**.
2. Select **masked password and mobile authorization** from the drop-down list.
