What is this product?

Type: Shares of a Sub-Fund of Lyxor Index Fund, a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Fund is an index-tracking UCITS passively managed.

The investment objective of the Fund is to track both the upward and the downward evolution of the MSCI ACWI IMI Robotics & AI ESG Filtered Net Total Return Index (the "Index") denominated in US Dollars (USD), while minimizing the volatility of the difference between the return of the Fund and the return of the Index (the Tracking Error").

The anticipated level of Tracking Error in normal market conditions is indicated in the prospectus.

The Index aims to represent the performance of a set of companies associated with the increased adoption and utilization of artificial intelligence, robots and automation while excluding those involved in certain controversial businesses or with relatively low Environmental, Social and Governance (ESG) controversies and ratings scores.

The ESG rating methodology is based on ESG key issues including but not limited to water stress, carbon emissions, labor management or business ethics. The Index uses a "Best-in-class" approach, i.e., bottom quartile companies by ESG industry-adjusted rating are excluded from the theme universe. For further information in relation to the general and specific environmental, social and governance (ESG) objectives targeted by the Sub-Fund, please refer to the Transparency Code of the Sub-Fund available on https://www.lyxoretf.com/. Limits of the methodology of the Index are described in the prospectus of the Fund through risk factors, such as the market risk linked to controversies and the risks linked to ESG methodologies and to ESG score computation. MSCI's website (www.msci.com) contains more detailed information about the MSCI indexes.

The Index is a net total return index. A net total return index calculates the performance of the Index constituents on the basis that any dividends or distributions are included in the Index returns after withholding tax retention.

The Fund seeks to achieve its objective via indirect replication by entering into an over-the-counter swap contract (financial derivative instrument, the

"FDI").

The Fund may also invest in a diversified portfolio of international equities, whose performance will be exchanged against the performance of the Index via the FDI.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the Lyxor Index Fund prospectus.

Distribution policy: As this is a non-distributing share class, investment income is reinvested. the accumulation share automatically retains, and reinvests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

This product is designed for medium-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.

Order schedule: Orders to redeem shares must be received before 06:30 PM Luxembourg time no later than one (1) Business Day before the Valuation Day. Please refer to the Lyxor Index Fund Prospectus for further details regarding redemptions.
